Appearance/Odor: Viscous liquid, mild ester odor.

Steps to be Taken in Case Material is Released or Spilled: Dike and contain the spill with inert material (i.e., sand, earth, sawdust) and transfer liquid and solid diking material to separate containers for recovery or disposal.
